Discuss and Consider Approval of Minutes for the April 20, 2017 Meeting

Terry Marak explained that we have depository accounts with First National Bank of Central Texas and would like to extend the contract for 2 years. The board approved the contract extension.

Discuss and Consider Approval of Purchasing an SUV for the ESC 12 Fleet

Terry Marak shared that we are looking to replace the Trailblazer with a larger, used SUV for group travel. ESC Region 12 requested bids on a used SUV. Since no other bids were received, ESC Region 12 recommends that the Board approve a purchase of a used SUV from Enterprise Used Vehicle Sales. The board unanimously approved the purchase.
