The meeting was called to order by Chairman Bill Killian.

Administer Oath of Office to Board Members

Mr. Bill Killian and Mr. Kerry Hansen were administered the Oath of Office and sworn in to the ESC Region 12 Board of Directors.

Reorganize the ESC Board of Directors

Dr. Maze opened the floor for nominations to reorganize the Board. The motion was made by Rex Daniels to leave the Board as is and it was seconded by John Turpin. The Board of Directors unanimously agreed to leave the Board as is.

Discuss and Consider Resignation of Board Member Bill Tarleton

Mr. Bill Tarleton submitted his resignation to the Board on March 29, 2021 due to his move from Hill County. A replacement is forthcoming.

Discuss and Consider Approval of Minutes for February 25, 2021 Meeting

Discuss and Consider Approval of Financial Reports

Mr. Terry Marak discussed the monthly financial reports, which included the bills paid as of January 31, 2021 and February 28, 2021, the board report as of February 28, 2021, the interest earnings, and cash flow reports. The board unanimously approved all financial reports submitted.

Discuss and Consider Approval of Mid-Year Budget Amendment

Mr. Marak presented a mid-year amended budget by fund type and function for fiscal year ending August 31, 2021. The board unanimously approved the mid-year budget amendment.

Discuss and Consider Approval of Request for Proposal for SDSS 20-21

Mr. Marak explained that ESC Region 12 issued an RFP for Student Data Summary Software (SDSS). The Center uses this software internally to analyze district/charter PEIMS data in the course of providing various services to our customers. ESC Region 12 also sells this software to our district/charters on an annual basis. ESC Region 12 management requests that the ESC Region 12 Board of Directors approve the purchase of the SDSS from Aloe Software Group. The board unanimously approved Aloe Software Group for the purchase of SDSS.

Discuss and Consider Approval of Request of Purchase of Service from Summit K12 for District Literacy Services

The Education Service Center Region 12 requested a quote for an English Language Proficiency Program to assist school districts in closing the English language and academic vocabulary gap between ELL students and non-ELL students. Based on information obtained, the ESC 12 management requests that the ESC Region 12 Board of Directors approve the purchase of the English Language Proficiency program from Summit K12. The Board unanimously approved the purchase of Summit K12.

Discuss and Consider Purchase of Training Materials for the Texas Home Learning Grant (THL)

Ms. Charlene Simpson explained the details of the THL grant and how it affects ESC Region 12. TEA has authorized all twenty Education Service Centers to purchase training materials through a specific vendor without going through the official bid process.

Discuss and Consider Approval of Common Area Furniture

The Education Service Center Region 12 requested quotes for common area furniture in various areas of the Center. Three bids were received with only one vendor bidding furniture that compliments the recently renovated buildings. Based on this criteria, ESC Region 12 management requests that the ESC Region 12 Board of Directors approve the purchase of common area furnishings up to \$130,000 from MooreCo (PPG).
